## 1. The Financial Services Authority (FSA)

---

The FSA is the independent watchdog that regulates financial services. It requires us to give you this document. Use this information to decide if our services are right for you.

## 2. Whose mortgages do we offer?

---

- We offer mortgages from the whole market.
  - We only offer mortgages from a limited number of lenders.
  - We only offer mortgages from a single lender

## 3. Which service will we provide you with?

---

- We will advise and make a recommendation for you after we have assessed your needs.
  - You will not receive advice or a recommendation from us. We may ask some questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.

## 4. What will you have to pay us for this service?

---

- No fee. We will be paid by commission from the lender
- A fee of £250 payable on application. We will also be paid commission from the lender
- A fee of £250 payable on application and a fee of 1.5% of the loan amount payable when your mortgage completes. We will refund any commission payable to you.

You will receive a key facts illustration when considering a particular mortgage which will tell you about any fees relating to it.

**8. Are we covered by the Financial Services Compensation Scheme (FSCS)?**

Mortgage advising and arranging is covered for 100% of the first £50,000 so the maximum compensation is £50,000.
